

Pipeline Blast Mitigation Technology Report

The Pipeline Blast Mitigation Technology Report is a 205 page, color illustrated, spiral bound report on 8 ½ x 11 paper. It includes a survey and evaluation of existing blast mitigation technology, identification and assessment of the vulnerability of the US pipeline system, and the results of a test program to verify the performance of pipeline blast mitigation technologies. This report will be of use to the pipeline industry, companies that produce the products that travel by pipeline and various government organizations such as the Transportation Security Administration and the Department of Homeland Security.
